Course design

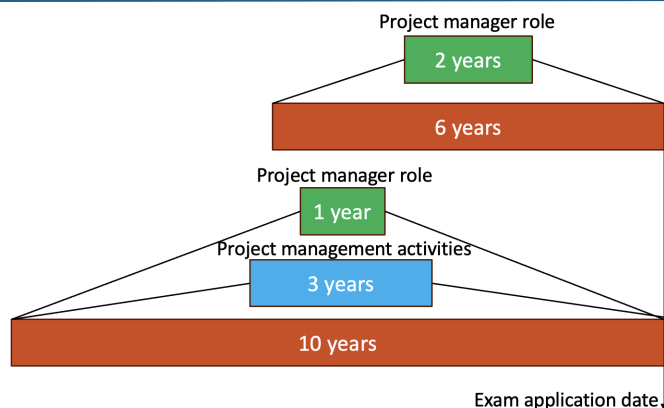
Certification path defined by ACCREDIA:

REQUIREMENTS:

Education: Minimum high school diploma requirement

Project Management Training: At least 35 hours of Project Management training. (requirement starting from the 2022 version of UNI11648)

Experience: at least two years as Project Manager in the last 6 years or having carried out Project Management activities for at least 3 years plus at least 1 year as Project Manager in the last 10 years



1. §A.2 Non-formal learning: it is believed that 35 credits in the project management discipline can be acquired following a 35-hour course previously recognized in the preliminary phase by the Certification Body, in relation to the content programme;

2. §A.2 Informal learning: work experience must be documented, the mere presentation of a self-declaration pursuant to Presidential Decree 445/2000 or a Curriculum vitae without proving documentation are not sufficient to satisfy the requirement. As further support, the candidate is also required to present a project report, of which the candidate has acted as Project Manager, according to the indications in Appendix C of UNI 11648:2022;

3. §A.3 Applicable assessment methods: the knowledge and skills assessment exam must include:

- a written test with at least 50 closed-ended questions of which for 4 answers only 1 is correct (those of the "true/false" type are excluded). The maximum duration of the test is established at 90 minutes. The test is considered passed with a minimum score of 70%, i.e. a score equal to or greater than 35/50).
- a written test with at least 4 open-ended questions, or case studies, applications or simulations of real operational situations related to the professional activity or a combination of them. The test lasts 90 minutes. The test is considered passed with a positive evaluation of at least 70%. Please remember that the minimum duration of the 2 written tests cannot be less than 180 minutes;
- an oral test with at least n. 3 questions necessary to investigate any uncertainties found in the written tests, ascertain the level of skills acquired by the candidate, investigate the project report presented by the candidate in the preliminary phase. The test is considered passed with a positive evaluation of at least 70%.

Certification bodies recognized by ACCREDIA certify the skills of the Project Manager, pursuant to the UNI 11648:2016 standard, according to the scheme accredited by ACCREDIA.

Below is a summary table of the main CBs, which are constantly growing, which we recommend analyzing updated on the ACCREDIA website.

Each CB adopts its own independent commercial policies, in fact costs must be considered for:

- the preliminary investigation phase
- take the two written tests and the oral test
- be included in the public register of certified persons of the CB
- the renewal, surveillance and maintenance of certification

The A4PM[®] course has been qualified by ACS, an OdC (Certification Body) recognized by ACCREDIA and is present in the database of qualified courses with the register number 43, in the three modes in which A4PM[®] has specialized over the years:

A4PM is an Examination Center for the professional Certification of Project Manager according to the UNI 11648:2022 standard

We certify Project Managers in accordance with the UNI 11648:2022 standard as an Evaluation Body, on behalf of ACS ITALIA (CSQA group), a publicly controlled Competence Certification Body, with a scheme accredited by Accredia.

We organize an exam session every month, exclusively online, to meet the needs of those professionals who do not have the time or means to go to one of our offices.

The UNI 11648:2022 Project Manager certification exam consists of three exam tests. Passing the exam requires reaching the minimum threshold of 70% of the maximum score achievable for each test. The assessment of the Candidate's suitability, for the purposes of issuing the ACS certification, occurs through the temporal and binding sequence of each of the following phases:

- **PHASE 1:** Evaluation of the documentation produced by the Candidate to verify possession of the requirements requested by the Scheme. It will be the candidate's responsibility to send an email to: odv@a4pm.eu with a CV that highlights the experience as a Project Manager to verify the presence of the prerequisites expressed by the UNI 11648:2022 standard.
- **PHASE 2:** Certification exam, for the evaluation of knowledge, skills and competences, carried out by the Examination Commission.
- **PHASE 3:** Internal review of the documentation and exam results by the Examination Commission. The scores achieved by each candidate will be taken into account objectively, in each exam taken. Passing the exam requires the minimum threshold of 70% of the maximum score achievable.
- **PHASE 4:** Sending the exam dossier to ACS Italia. Approval of the certification proposal by the Decision Maker and issuing of the certificate and registration in the ACS Register published on www.acsitalia.it and ACCREDIA.

Conducting the exam tests:

The exams are held remotely via the Google Meet or ZOOM platform with the presence of a supervisor.

The exam is recorded via the Google Meet platform and supervised with screen sharing, moreover, the examiner will be able to observe the progress of the exam and the behavior of the candidate, with the use of the webcam of his smartphone. **The exam is held in Italian.**

The exam test consists of:

- a written test with 50 closed-ended questions, of which only 1 is correct for 4 answers (excluding "true/false" answers) aimed at verifying knowledge. The maximum duration of the test is 90 minutes. The test is considered passed with a minimum score of 70%, or a score equal to or greater than 35/50).
- a written test with a complex case study, relating to project situations, designed to evaluate the skills acquired by the candidate, consisting of 5 open-ended questions. The test lasts 90 minutes. The test is considered passed with a minimum score of 70%, or a score equal to or greater than 21/30).
- an oral test with at least 4 questions necessary to investigate any uncertainties found in the written tests, ascertain the level of skills acquired by the candidate, examine in depth the project report presented by the candidate during the investigation phase and finally, a question on the discipline, on the best practices of project management. The test is considered passed with a minimum score of 70%, or a score equal to or greater than 14/20). The maximum duration of the test is set at 60 minutes.

During the tests, the use of the following is permitted:

- A system calculator (Windows or IOS)
- The use of a blank Word page on your PC to take notes during the exam. The Word page cannot be saved in any way and at the end of the test it must be closed without saving.

The supervisor's duties are:

- Verify the identity of the candidate using a valid identification document.
- Verify the suitability of the workstation from which the candidate carries out the exam, verifying the absence of foreign objects and requesting their removal if necessary.
- Request screen sharing during the test.
- Verify the smooth running of the tests, in accordance with these regulations, and in particular the observance of the prohibitions that he will list before the start of the tests.

Prohibitions

- It is forbidden to use any writing support (sheets, post-its, block-notes, etc.) with the exception of those allowed
- The presence of other people during the exam is prohibited
- It is forbidden to look outside the screen
- The use of headphones of any type is prohibited
- It is forbidden to turn off the webcam of the PC and smartphone
- The use of double screens is prohibited
- It is forbidden to have applications other than Google Meet and Google Forms open on your PC
- The use of the smartwatch is prohibited
- It is forbidden to get up from your seat during the exam
- It is forbidden to use your smartphone and move it from its position
- It is forbidden to ask questions of the supervisor during the exam.

Following the possible passing of the A-PM[®] and C-PM[®] Project Management certifications (summarized in the table as AC-PM[®]), you will be entitled to directly access the oral exam with a Certification Body recognized by ACCREDIA.
